All shares of Common Stock subject to the award are deferred into the United Community Banks Deferred Compensation Plan and will remain deferred until termination of service as a director and officer in accordance with the terms of the plan, at which time they will be distributed in equal installments over a period of five years. No consideration was paid by the reporting person in connection with this award.
- Includes 77 shares owned by Mr. Tallent's wife for which he claims beneficial ownership.
- Includes 61 shares owned by Mr. Tallent's minor grandchildren for which he claims beneficial ownership.
